- ◆ Good attendance with hot weather experienced
- ◆ Closing date will be determined by the weather
- ◆ Pool closed for one day at end of February due to equipment breakdown
- ◆ Will work with Pahiatua Pool Committee on areas of mutual benefit

8. Lindauer Studio

- ◆ Flooring to be finished
- ◆ Leaks in windows – Joiner to fix
- ◆ Looking for assistance with the building of the website – Claire suggested that Tararua College be contacted as students may be able to assist. Roger Twentyman also offered Council support for this project if required.
- ◆ Two more original Lindauer's have been found and photographed and there are now nine prints ready to process
- ◆ Query re numbers- there is no door counter but traffic has increased due to the link

9. Business Group
- ◆ Everyone busy with own businesses over the last couple of months and there has been no activity to report; they will reconvene this month

10. Tararua District Council
- ◆ Eketahuna also having problems re agencies at the Heartland Centre
  - ◆ Speed limit policy adopted for consultation
  - ◆ Capital works – Fergusson St drain nearly completed. All programmed capital works should be finished by end of financial year subject to weather conditions
  - ◆ Skatepark – offer has been made for the section, waiting for completion

11. Ormond House
- Letters requested to be sent at last month's meeting have not yet been written as Paul has been seeking more information
- He spoke to the Coordinator of Pahiatua Heartlands who advised
- Pahiatua Centre is visited by five organisations, WINZ, IRD, Ministry of Justice, Maori Land Court and Community Law Services.
  - Ministry of Social Development pay for the lease, power, phone and coordinator

WINZ advised that there were problems with computer access in Woodville. Also security issues raised as only one person in the building at a time. Paul advised that the letters will be written early this month.

Carolyn advised the meeting that she had been contacted by Colmar Brunton undertaking a survey regarding Heartland Services recently.

Ian stated that Woodville is severely disadvantaged with there being no access to LTSA services in Woodville. People leave the town to register their vehicles etc and shop out of town. There should be a coordinated approach to request an agency in Woodville.

12. Waireka Home
- ◆ Has been a complete restructuring
  - ◆ A number of staff redundancies occurred
  - ◆ Still seeking ways to find more funding
  - ◆ 100% occupancy with a waiting list at present

- 13.1 General Assistance Grants:

- 13.2 Kiwi Sanctuary in Manawatu Gorge
- Lloyd Robins spoke on this proposal and is looking for support.

Goals: 1 To establish effective long term control of pest species  
2. To introduce species as they become available including kiwi, kokako and kaka

- ◆ The intention would be to concentrate on south side of Gorge
- ◆ Friends of Manawatu Gorge concept
- ◆ DOC are helpful if you have a plan.
- ◆ Meeting generally in support; those members interested to meet with Lloyd and report back to the next meeting
- ◆ Woodville Domain Board has control of a considerable amount of land at the southern end of the Gorge. They should also be contacted.

### 13.3 Anzac Day

- ◆ Dawn service – RSA organise

### 13.4 Camping Ground

- ◆ Post Office Tavern currently providing keys and taking money
- ◆ Council acknowledgement would be appreciated
- ◆ Need to look at whether to charge a key deposit
- ◆ Possibility of WDV leasing the camping ground for a peppercorn rental and running the facility

### 13.5 Personal Safety

- ◆ A number of older single women in Woodville are concerned about their personal safety as there is a problem with uncontrolled teenager/sub teenagers
- ◆ Vehicles are being vandalised; when this is reported not receiving a positive response
- ◆ Incidents reported through the 111 system appear not to have been passed on to local station.
- ◆ Taking up to 40 minutes for a response to calls
- ◆ Carolyn advised that these incidents should also be brought to the attention of the Tararua Safer Community Council who have ongoing liaison with Police

### 13.6 Local Services Mapping – Anna Purger

- ◆ The aim is to improve the development, planning, delivery and funding of services to families in the community.
- ◆ Three phases
  - Stocktake of existing services and funding groups
  - Analysis of needs, gaps, strengths and issues for the local community
  - Agreement and implementation of an Action Plan
  - There is a steering group organised for Tararua
