Thank you for your enquiry about the progress on options to recover the portion of funds relating to the foregone interest on the Pūkaha loan, as discussed at the Council meeting on 30 July 2025.

These options will be considered as part of Council's work on the Annual Plan for the 2026–27 financial year. The Annual Plan workshops will be open to the public and will also be livestreamed for anyone who would like to follow the discussions.

You also asked about the Contestable Fund, which was mentioned as one possible avenue to look into, to recover some of the cost. The District-wide Contestable Fund was created by Council to support local groups and individuals who want to make a positive difference in the Tararua District.

The fund provides \$100,000 each year and is open to not-for-profit groups, organisations, and individuals within the district. It supports projects that contribute to:

- A thriving district
- Local culture and traditions
- Improvements to the local environment
- Improvements to local infrastructure
- Community wellbeing
- Stronger collaboration

Applications are invited twice a year.

Regarding the repayment of the loan itself, the minutes from the 30 July 2025 Council meeting (which you have a copy of) explain that repayment is guaranteed through a Deed of Guarantee and Indemnity. This arrangement addresses the risk of financial default under the loan and reduces the risk of any loss to Council. All documents were legally reviewed, key clauses were discussed with the parties involved, and everyone agreed to the terms. The Guarantee and Indemnity protects Council in the event of any default. Progress on repayment of the loan would also be reported through Council's Annual report, ensuring transparency to the community.

I hope this explanation makes things clearer. If you need anything further, I'm happy to help.

I would like to hear what progress has been made Chief Executive for recovering interest through the Contestable Fund. Also who or what is the Contestable Fund?

I refer to your official information request dated 28 October 2025 for information about the million dollars loan to Pukaha Mt Bruce.

At its meeting on 30 July 2025, the Tararua District Council agreed to transfer the loan to Tū Mai Rā Investments Limited Partnership. The partnership will take care of repaying the loan principal, though the interest isn't part of their responsibility.

To make sure the interest is still addressed, Council asked the Chief Executive to prepare a report with options for recovering it through the contestable fund. You'll find a copy of the meeting minutes attached.
