Reasons for submission (continued)

Current Quarry consent conditions require that dust does not cause a nuisance beyond boundary. For a solar farm any dust will be an issue. Quarry operations would not be able to comply with consent conditions unless all tracks were sealed to prevent dust from heavy truck movements, crusher plants were enclosed, and regular (daily) sucker truck sweeping implemented. The quarry would also need to install expensive monitoring solutions to demonstrate they are not the cause of any dust build up on the solar panels which can come from many sources in a rural setting including the river banks in dry summer conditions.

We would like to support the proposal if consent conditions do not stop or negatively impact existing consented land use or business operations.

We request that council require the applicant to open discussions with existing neighboring business's operations to see if a mitigation plan that is acceptable to all parties can be achieved and that any future issued consents recognizes any such agreements.
