Extract from the Local Government (Rating) Act 2002

Section 20. Rating units in common ownership—

Two or more rating units must be treated as 1 unit for setting a rate if those units are—

- (a) owned by the same person or persons; and
- (b) used jointly as a single unit; and
- (c) contiguous or separated only by a road, railway, drain, water race, river, or stream.
