

TDC'S COMMUNITY DEVELOPMENT SERVICE

Aim:

To support our communities to achieve their desired outcomes.

What is the service?

Community Development was introduced as a new and growing service in the 2021-31 Long Term Plan. The service is focused on the following objectives:

- » Better connect Council decision-making to desired community outcomes;
- Provide ongoing community input into Council Long Term and Annual Plan processes through community-led planning;
- » Access external funding for Council projects; and
- » Assist community groups and projects with regulatory barriers and access to external funding.

FUNDRAISING SUPPORT

Discussion with a range of community organisations has identified a strong need for support with fundraising. Many organisations are not applying for funding that is currently open to them due to lack of resources and/or skills.

Council now provides support for fundraising:

- » Helping groups and individuals access funds by directing to funding portals and databases
- » Connecting groups and individuals to funders that can provide advice and guidance on where and how to apply
- » Supporting non-commercial groups and individuals with applications to funds (with the aim of up-skilling groups to be able to complete applications independently in the future)

The Central Energy Trust (CET) was created on the establishment of CentralPower Limited in 1993.

In 2001 the Trust realised its interest in the company when Powerco merged with CentralPower Limited, and became the controlling entity.

The capital fund arising from the sell down has been invested in fixed interest securities and equities, and the resultant income is available for distribution.

Grants

CET provides grants to community, sporting, educational, cultural and health organisations within the Manawatu/Tararua regions for projects which are energy-related and which will benefit the consumer's of the former CentralPower/ ElectroPower energy companies (see website or scan QR code for map).

Bursaries

Each Bursary will be awarded for up to three years and have a value of up to \$4,000, with the period and amount dependent on the type and duration of study. Half of the bursary is normally paid for the first year of study and the balance in equal instalments over the remaining period of the bursary.

Ngā Ratonga Kaupapa Atawhai (Charities Services), is part of Te Tari Taiwhenua (The Department of Internal Affairs), and administers the Charities Act. One of our core functions is maintaining the Charities Register. This is the public record of the over 28,000 registered charities that operate under the rules of the Charities Act.

The scheme is a partnership between Tararua District Council and Creative New Zealand that helps to fund local arts projects.

There are two funding rounds each year in March and September. If there are no rounds open, you can still get in touch with us to discuss your options and find out if this is the right fund for you.

To get funding through the scheme, your arts project must do at least one of the following:

create opportunities for local communities to engage with, and participate in, arts activities

support the diverse arts and cultural traditions of local communities

enable and encourage under-18s to engage with the arts

To be eligible for funding, your project must:

have an arts or cultural focus

take place within Tararua District

benefit local communities

not have started before an application for funding has been assessed

not have been funded by Creative NZ for the same purpose

Community Organisation Grants Scheme (COGS) grants funding to community-based social services that contribute to local outcomes for:

on-going operational costs

community projects or events

Lottery Community Fund grants funding to help improve the quality of people's lives in the community:

on-going operational costs

community projects or events

minor capital works projects valued at \$50,000 or less

community development costs, such as hui, training, planning, evaluation and facilitator fees

Eastern & Central Community Trust (ECCT) provides grants and support to community organisations operating in the Gisborne Tairāwhiti, Hawke's Bay, Tararua, Manawatū, Horowhenua and Wairarapa districts. There are two main funds open for grants on an ongoing basis:

The Grassroots Fund is to ensure communities have access to services, events and initiatives that they value. It is designed to support a broad range of positive activities that contribute to ECCT's Priority Communities, to achieve our vision. In general, funding can go towards operating costs, programme costs, coaching, events, equipment, small assets, vehicles, repairs, and maintenance, and grassroot regional or local activities. The Grassroots Fund is contestable and can grant up to \$30,000 (GST excl.). Capital projects can receive up to \$75,000 (GST excl.)

The Community Assets Facilities Fund (CAFF) is designed to help communities create and maintain the community assets and facilities needed to meaningfully participate in community life. This fund is for projects that need funding of between \$75,000 - \$500,000. If you have a community asset that needs to be built, developed, or maintained, have a conversation with us about how we may be able to help.

Please note: we are unlikely to fully fund a project by ourselves. We may ask if you have other funders arranged, and how much you will be putting towards a project yourselves. If interested in the CAFF – the first step is to speak to our Community Advisor who will guide you through the process.

Commemorating Waitangi Day Fund

The Commemorating Waitangi Day Fund supports events that commemorate the signing of the Treaty of Waitangi, and promote nation and community building. The Fund aims to encourage a wider mix of communities to take part in Waitangi Day events.

Applications for the 2024 Commemorating Waitangi Day Fund will open in September 2023. The Fund will distribute up to \$300,000 total to support events that encourage communities to participate in commemorating the signing of Te Tiriti o Waitangi / the Treaty of Waitangi.

We are especially keen to support events organised by local government and/or communities in partnership with tangata whenua that invite wide community participation, and that deepen and broaden the conversations about the Treaty of Waitangi and deepen understanding across communities.

Ngā Kōrero Tuku Iho New Zealand Oral History Grants

Ngā Kōrero Tuku Iho New Zealand Oral History Grants are available for community-led projects reflecting diverse identities and perspectives. Administered by Manatū Taonga Ministry for Culture and Heritage, this funding provides financial help for oral history projects relating to the history of Aotearoa New Zealand and Aotearoa New Zealand's close relationships with the Pacific.

Funding for these grants came from the Australian Sesquicentennial Gift Trust for Awards in Oral History in 1990 to honour 150 years since the signing of Te Tiriti o Waitangi. Each year approximately \$100,000 is divided between the successful applicants (usually a maximum of 12 grants are given). Since 1991, when they were first awarded, more than \$2 million has been given to more than 400 community groups and individuals. A successful applicant generally receives between \$5,000 and \$10,000 towards the costs of their project.

Applications are assessed by a committee comprising people from around the country who have a range of experience with oral history and oral traditions.

Grants are given as a contribution towards the cost of recording interviews for oral history projects. They may be used to pay training, travel and other expenses, such as having relevant photographs copied. The purchase of good quality audio and/or video recording equipment may also be supported if the application includes a quote from a retailer.

The next funding round will close on 15 April 2024.

Whiria Te Mahara New Zealand History Grants

Whiria Te Mahara New Zealand History Grants, funded by the New Zealand History Research Trust Fund, support historians, researchers and writers working on non-fiction projects that will significantly enhance our understanding of New Zealand's past.

Every year the fund gives away 8-12 grants of up to \$12,000 each to fund research and writing costs. We usually receive around 60-80 applications. These grants are administered by the Ministry for Culture and Heritage. A committee of senior historians from outside the Ministry recommend who will receive funding.

Any individual or group can apply. We are particularly keen to receive applications for projects dealing with Māori topics. Traditionally, we have supported projects that produce print publications, such as books. We prefer funding book projects with a wide target readership, rather than academic journal articles.

We also consider digital formats such as web stories and online exhibitions, provided the funding is only for the historical research and writing component, not design and development costs.

If your topic is regional, or about your family, you are welcome to apply, but we need to know how the project would enhance understanding of the nation's history.

Applications close on 15 October every year, and all applicants will be notified of the outcome by early December.

Pub Charity is at the heart of community funding.

Pub Charity distributes grants to worthy community organisations all over New Zealand through the funds raised in gaming machines hosted in our member hotels and taverns.

We first began raising grants funds for New Zealand communities in 1987. That's 30 years of excellent partnerships with our venues and 30 years supporting communities all over New Zealand.

In June 2023, we gave an impressive \$3.3m in grants to New Zealand communities. Grants were distributed to a number of groups and causes including sports groups; health, disability and welfare support organisations; education and research institutions; community organisations; environmental and animal charities; and arts and culture.

All applications must meet Pub Charity Limited's funding criteria. Before applying, check our website to make sure that you meet our Grants Criteria and that your application is for an Authorised Purpose. It is also a good idea to check our FAQs page as this will clear up a number of common issues.

Each month our Net Proceeds Committee, made up of members of the Pub Charity Board, meets to decide the outcome of our grant applications. All applications for grants funding raised in Pub Charity Limited member hotels and taverns must be received by 5:00 pm on the grants cut-off date. If your application isn't received on time, it will be considered in the following month's application round.

Additional to providing Race and Sports betting within New Zealand, TAB New Zealand (TAB NZ) also operates gaming machines within standalone TAB NZ Venues throughout New Zealand.

Whilst the majority of the profits from the Gaming operation are used to support the racing industry through the promotion, control and conduct of a race meeting, up to 20% of profits are made available for the support of amateur sports organisations across New Zealand via gaming grant funding.

TAB NZ endeavours to maximise the gaming grant funding available to support bonafide organisations with the costs associated with the 'playing of the sport' in the first instance. As such, grant funding is prioritised on travel and accommodation costs to attend domestic tournaments, pooled resources such as playing uniforms and/or playing or training equipment as well as facility/court hire or playing ground maintenance.

Organisations looking to apply for a grant should familiarise themselves with the TAB NZ 'Sports' Authorised Purpose Statement and the TAB NZ Eligibility and Prioritisation Policy.

The **Rural Travel Fund** was established in 2003 with the purpose being to "remove the barrier of cost to participation for those in rural "communities". The Fund is administered on Sport NZ's behalf by thirty-five eligible provincial councils across Aotearoa.

The objective of the Fund is to provide quality sport opportunities and experiences for tamariki (children aged 5-11) and rangatahi (young people aged 12-18), with an emphasis on providing sport experiences for girls and young women (5-18); and/ or disabled tamariki (5-11) and rangatahi (12-18).

Applications open in March and close in April each year. When the funding round is open the guidelines and application form will be available on the Tararua District Council website, or can be collected in hard-copy from a Council Service Centre.

The **International Representatives Scheme** was established to provide funding for amateur athletes when selected to represent New Zealand, through the national body and/ or international body's qualifying criteria, for an international event where two or more countries are participating.

> Applications are open year round, however, all applications must be submitted (and accepted as complete) *at least* one month prior to travel.

Waireka Community Trust seeks to make a positive impact on the communities of Pahiatua, Eketāhuna and Woodville by making charitable distributions in the area.

The Trust funds invested have been successfully managed by Craigs Investment Partners since 2008.

For the 2020 year the Trust had a return on investments of \$347,806 (2019: \$477,361). This represents a return of 7.8%.
