

GRANTGURU

Community groups and businesses in the Tararua District can now find grants more easily with the new Tararua Grant Finder.

Tararua Grant Finder hand-picks grants and funding opportunities specific to local businesses and community groups. Organisations and individuals can use the search engine to find available grants and filter them by specifying industry and type of project.

Tararua District Council has joined forces with New Zealand and Australia's most powerful grant search engine, GrantGuru, to deliver a free one-stop-shop grants portal. It is free for community, business, and residents to use to seek funding for their goals, projects, events, and/or services.

Users can register to receive alerts about funding programs relevant to them as they become available, allowing for the opportunity to plan and submit well-prepared funding applications.

The ANZ Staff Foundation is a charitable trust funded by contributions from ANZ employees, providing financial support to community organisations throughout New Zealand.

It aims to support projects that create tangible benefits for local communities, focusing on improving well-being and outcomes in various areas such as education, health, the environment, and financial literacy.

Registered charities and non-profit organisations in New Zealand are eligible to apply. The foundation typically funds initiatives that deliver clear community benefits, with an emphasis on small, grassroots projects where the funding can make a significant difference. Grants are often awarded for specific purposes such as equipment purchases, community programs, or infrastructure improvements.

The ANZ New Zealand Staff Foundation normally has two funding rounds per year. These are ordinarily open for applications between:

- 1 January 5pm on 15 February, or on the next business day if 15 February falls on a weekend or public holiday
- 1 July 5pm on 15 August, or on the next business day if 15 August falls on a weekend or public holiday

The Central Energy Trust (CET) was created on the establishment of CentralPower Limited in 1993.

In 2001 the Trust realised its interest in the company when Powerco merged with CentralPower Limited, and became the controlling entity.

The capital fund arising from the sell down has been invested in fixed interest securities and equities, and the resultant income is available for distribution.

Grants

CET provides grants to community, sporting, educational, cultural and health organisations within the Manawatu/Tararua regions for projects which are energy-related and which will benefit the consumer's of the former CentralPower/ ElectroPower energy companies (see website or scan QR code for map).

Bursaries

Each Bursary will be awarded for up to three years and have a value of up to \$4,000, with the period and amount dependent on the type and duration of study. Half of the bursary is normally paid for the first year of study and the balance in equal instalments over the remaining period of the bursary.

CHARITIES SERVICES

Ngā Ratonga Kaupapa Atawhai

Ngā Ratonga Kaupapa Atawhai (Charities Services), is part of Te Tari Taiwhenua (The Department of Internal Affairs), and administers the Charities Act. One of our core functions is maintaining the Charities Register. This is the public record of the over 28,000 registered charities that operate under the rules of the Charities Act.

We also have resources and webinars to help with becoming a registered charity, annual reporting and governing your charity. For more information visit our website www.charities.govt.nz.

One-on-one clinics with Charities Services every Thursday

Come and talk to our team and get answers to the questions you have about being a registered charity. Appointments are available every Thursday with Charities Services staff to discuss, advice on your rules, advice on changing your purposes or activities, financial reporting, and governance.

The scheme is a partnership between Tararua District Council and Creative New Zealand that helps to fund local arts projects.

There are two funding rounds each year in March and September. If there are no rounds open, you can still get in touch with us to discuss your options and find out if this is the right fund for you.

To get funding through the scheme, your arts project must do at least one of the following:

create opportunities for local communities to engage with, and participate in, arts activities

support the diverse arts and cultural traditions of local communities enable and encourage under-18s to engage with the arts

To be eligible for funding, your project must:

have an arts or cultural focus take place within Tararua District benefit local communities

not have started before an application for funding has been assessed not have been funded by Creative NZ for the same purpose

The Department of Internal Affairs provides support and information about Central Government and Lottery funds available to community organisations and charities.

Community Organisation Grants Scheme (COGS) grants funding to community-based social services that contribute to local outcomes for:

on-going operational costs community projects or events

Lottery Community Fund grants funding to help improve the quality of people's lives in the community:

on-going operational costs

community projects or events

minor capital works projects valued at \$50,000 or less

community development costs, such as hui, training, planning, evaluation and facilitator fees

Eastern & Central Community Trust (ECCT) provides grants and support to community organisations operating in the Gisborne Tairāwhiti, Hawke's Bay, Tararua, Manawatū, Horowhenua and Wairarapa districts. There are two main funds open for grants on an ongoing basis:

Community Support & Event Fund – This is a quick response grant for community organisations that deliver valuable community services, events, and other community initiatives that align with our strategic direction. For events, they must be accessible for the community – be free or low-cost entry. Events must encourage participation and have widespread appeal within the community. The grant is to a maximum of \$10,000.

Community Impact Fund - This fund supports community organisations who deliver initiatives and services that create real impact with our Priority Communities and our Pou | Pillars. The fund encourages organisations to seek innovative ways to address issues in the community. Greater weight will be given to projects that deliver across multiple Priority Communities and Pou. This grant is between \$10,000 and \$100,000. Note there is a higher level of evaluation and reporting.

Please note: We are unlikely to fully fund a project by ourselves.

We may ask if you have other funders arranged, and how much you will be putting towards a project yourselves if applying for a substantial programme or facility.

Fonterra is a New Zealand dairy Co-operative made up of everyday good people who work together to do good things, including supporting communities in need.

Fonterra support community groups, schools, iwi and the wider community by offering support through funding, volunteering or dairy products. Fonterra operate across 10 regions across New Zealand, led by Fonterra employees who live and work in the regions.

To be considered for support, your initiative or project would need to fit into one of the following pillars:

Putting good quality nutrition in the hands of those who need it most

Empowering communities to protect and restore nature

Partnering to keep our rural communities resilient and thriving

The fund will support registered charities or not for profit or a school or group; initiatives that have a wide impact on large groups or communities; donations of dairy products; or cash funding up to the value of \$5K.

The fund will not support projects that support meeting regulatory requirements or consent conditions; individuals or businesses for private gain; scholarship funding; any individual sportsperson; or overseas travel and accomodation. Additionally, the fund prefers to support sports clubs through dairy product however where fundraising isn't possible, a cash donation or equivalent value will be considered.

You can apply for funding if your project meets at least one of the Te Āpiti Community Fund objectives: Your project must promote environmental awareness and programmes that sustain and improve the quality of the environment in the community; contribute to the sustainability of non-profit organisations or volunteer services; promote life-long learning opportunities for all; foster the development of opportunities for sporting, social and recreational activities; or promote quality healthcare.

Your proposal must clearly outline what the outcomes and benefits of your project will be, and how your project will contribute directly to the community; generate benefits that do not currently exist; contribute long-term solutions to issues; foster the development of skills and capacity; demonstrate the ability to make effective use of the funds; have performance measures that focus on outcomes; provide promotional opportunities; use the fund to attract additional funding for the project; and demonstrate a sustainable future for the project beyond the support of the fund.

All applications for grants funding raised in Pub Charity Limited member hotels and taverns must be received by 5:00 pm on the grants cut-off date. If your application isn't received on time, it will be considered in the following month's application round.

The Tindall Foundation's Whānau/Families fund, managed locally by REAP Wairarapa and Tararua REAP, is focused on supporting initiatives that have a significant community impact.

The fund primarily targets tamariki (children), rangatahi (young people), and their whānau (families), especially those experiencing multiple and intergenerational disadvantages.

The vision behind the fund is to ensure that these families are resilient, secure, and thriving. Eligible organisations within the Wairarapa and Tararua regions, can apply for funding. The fund supports a range of activities such as early childhood development, youth programs, Māori initiatives, and services for migrants, refugees, cross-cultural projects, literacy and numeracy, community services and development. Grants range from \$500 to \$15,000 annually and can be provided for up to three years.

The fund specifically does not cover initiatives with a focus on health, disability, core education, sport and recreation, drama art or performing arts, or any project that is part of a core governmental funding.

To apply, interested parties must contact Kerri at Tararua REAP to obtain and submit an application form by mid-October, with allocations made in early November. Reports on the use of the grant are due the following July. Further details can be obtained through the provided contact information or by visiting the foundation's website.
