 - A surrender of registration of a food business subject to a national programme under section 98 of the Food Act 2014.

Collection of information

Collection of personal information

Pursuant to Principle 3 of the Privacy Act 1993, we advise that:

Failure to provide information under sections 64 and 71 is an offence under section 244 (penalty - fine up to \$20,000 for corporates and up to \$5,000 for individuals)
- Under Principles 6 and 7 of the Privacy Act 1993, you have the right of access to, and correction of, any personal information that you have provided.

Collection of Official Information

All information provided to Tararua District Council is official information and may be subject to a request made under the Official Information Act 1982.

If a request is made under that Act for information you have provided in this application, Tararua District Council must consider any such request in accordance with its obligations under the Official Information Act 1982 and any other applicable legislation.


