I refer to your official information request dated 29 July 2024, for the name and address of the owner of the rating unit at 29 Main Street, Eketāhuna.

The Local Government (Rating) Act 2002 sets out the requirements relating to inspection of the Council's rating database (Section 28D of the Act).

This section of the Act states that for the purpose of inspecting any information in relation to a particular rating unit, the Council rating information database must be made available for inspection. The inspection can take place at either the principal office of the Council, or at any of its other offices. The name of the owner of the rating unit, and the postal address of the owner of the rating unit, can be viewed at the inspection, unless the owner has requested under section 28C of the Act for this information to be withheld from the database.

We have checked with our Revenue Manager to ensure that no request has been made by the owner to withhold their name and postal address from the database, so this information should be able to be viewed at our Eketāhuna office.
