I refer to your official information request dated 10 September 2024 regarding number of staff attending Wall Walks courses, costs of attendance, plus information relating to sending staff on Wall Walks courses.

Our organisation held a wall walk course on 1 February 2023. This is the only course staff have attended. 35 staff attended this course.

A copy of the staff invitation to attend this course is attached. Attendance was voluntary.

A copy of the parts of the wall walk course that each team of staff was involved in is attached.

The total cost of attending this course was \$5,300.00.

There has been no other funding provided to wall walks.

We do not hold any information on measurable outcomes, therefore in accordance with the Local Government Official Information and Meetings Act 1987, section 17(e) "that the document alleged to contain the information requested does not exist or, despite reasonable efforts to locate it, cannot be found."

- The value of any other funding provided to wall walks, broken down by date, funding purpose, office location and amount.

- Please provide emails, reports, messages or any other correspondence for the reasoning of staff being sent on these courses and specify whether participation in these courses was compulsory or not.

- Please provide a copy of documentation including but not limited to emails, reports, messages or any other correspondence that explains the content included in the course or description of activities undertaken through wall walks, or any associated courses/training.

- Please provide emails, reports, messages or any other correspondence for any measurable outcomes from your agency attending Wall Walk courses.

We do not wish to cause unnecessary expense or burden for your agency. Should clarification be required, please call or email. Similarly, if a request proves unnecessarily burdensome in form and we are likely to be able to adjust that request

to be more specific or better suited to your information systems without losing the benefit of what is sought, please get in touch. If there is likely to be a delay in the assembly or provision of some of the information requested, please provide the balance as it becomes available.

In any place where possible, data that can be presented in an excel format is preferred to other methods of presentation e.g. PDF.
