I refer to your official information request dated 15 October 2025 for information re traffic counting contract.

The roading activity in the Tararua District is undertaken by the Tararua Alliance, which is a collaborative working agreement, or partnership, between Tararua District Council and Downer NZ Ltd to manage Council's transportation activity and water, wastewater, and stormwater reticulation infrastructure.

The Tararua Alliance performs the traffic counting internally, so there is no specific contract (apart from the Alliance one). This will continue until at least the end/renegotiation of the Alliance contract.

Therefore we are unable to provide the specific information you have requested, as there is no separate traffic counting contract and therefore this information does not exist. If there was, any price information would also be protected due to commercial sensitivity, under section 7(2)(b)(ii) of the Local Government Official Information and Meetings Act 1987.
